Event description

This interactive 2-in-1 workshops is organized to bring together results from DECIDE research involving 40+ collective energy actions, including energy communities across EU. The topics that will be tackled include:

- business models, financing and regulations;
- governance and legal forms;
- key performance indicators (KPIs) for progress;
- ways to include and collaborate with members with the collective/community.

DECIDE has defined seven categories of business models which are used by collective energy actions across Europe to create economic, environmental or social benefit to its members. The seven categories, together with business model canvases that provide specific examples based on DECIDE pilots are presented in the Structured overview of existing and emerging business models, related contractual conditions and recommendations. During the workshop we will build further on this work based on data collected through survey and interviews with initiatives outside of DECIDE project. We will present tools that can be used to measure the validity of planned business model. Together with you we will identify gaps and potential connections between regulation, technologies, financing and organizational structure that could enable further progress of collective energy actions across Europe.

In addition, through COMPILE and DECIDE project, the colleagues of Joanneum Research and in collaboration with collective energy actions across Europe have identified key performance indicators that can be used to measure the progress of the initiatives over time. These KPIs will be presented and discussed to identify which ones are the most useful for reporting, funding and monitoring the growth of the on the ground initiatives.
